 - Current system has Bands competing against each other regardless of size
 - Add clinician portion after performances?
 - Changing from MPA to Invitational may affect State Marching in future years
 - Do Not Publicly Announce Results of the Festival.
 - These two changes would be a positive experience for all groups participating in the event.
