- Voted on and APPROVED
- Motion APPROVED: MPA fees for ensembles up to 50 students will be \$250 + \$7.50 per additional student.
- Alex Olivas brings up that we should consider reimbursing clinicians more for driving.
  - Daniel Fear motions to reimburse clinicians for district events 65.5 cents per mile (IRS rate)
  - Seconded by AJ Carson
    - Alex Olivas motions to amend to 50 cents per mile
    - Seconded by AJ Carson
    - Voted on and APPROVED
  - Voted on original motion and APPROVED.
- David Schwartz proposes that we should consider charging a blanket fee for Honor Band participation.
  - Students pay one fee to audition, and participate if they are accepted into the ensemble.
- Motion by David Schwartz to have an all-inclusive \$25 fee per student for Honor Band (covers audition and participation for those students who are accepted), and each participating school is required to pay for a minimum 10 students + \$25 for each additional student.
