#### Nature of Work

Develop and implement a comprehensive band program for students. This includes teaching instrumental music classes, directing band performances, and fostering an appreciation for music among students. The teacher will create an engaging learning environment that encourages students to develop their musical skills and participate in school and community events.

- Design and implement a sequential music curriculum that aligns with state and district standards.
- Teach beginning, intermediate, and advanced band classes, ensuring appropriate differentiation for varying skill levels.
- Incorporate a variety of musical genres and cultural perspectives into the curriculum.
- Utilize technology and innovative teaching methods to enhance music instruction.
- Organize and direct band performances, including concerts, competitions, and community events.
- Collaborate with school administration to schedule performances and secure necessary resources.
- Assess and monitor student progress through formal and informal evaluations.
- Provide constructive feedback to students to support their musical development.
- Identify and support students with exceptional musical talents or specific learning needs.
- Establish and maintain a positive, inclusive, and safe classroom environment.
- Implement effective classroom management strategies to promote student engagement and discipline.
- Collaborate with colleagues, parents, and community members to support the music program and student success.
- Attend staff meetings as required.
- Maintain professional competence through in-service education activities provided by the district, and/or in self-selected professional growth activities.
